### 2 Purpose

### 3 Policy

This policy applies to all people working for and on behalf of Healesville CoRE across all venues and sites where it operates.

Healesville CoRE will communicate this policy to all active volunteers, contractors and other stakeholders as well as making it available to the general public.

Healesville CoRE has environmental protection expectations that it would like its volunteers, customers, suppliers, contractors and the community to follow, including:

1. Adhering to Healesville CoRE environmental policy;
2. Reducing waste through innovative work practices and recycling practices;
3. Reducing the consumption of resources associated with operations (e.g. energy, water, paper, plastic);
4. Minimising environmental impacts by reduction of polluting substances produced;
5. Increasing the use of environmentally acceptable materials, equipment and technology in place of those which are considered harmful;
6. Acting in a socially responsible manner at all times encouraging and fulfilling an environmentally friendly workplace;
7. Considering environmental aspects in the procurement of products and services, and endeavour to ensure suppliers meet high standards of environmental performance;
8. Minimising negative environmental impacts of our operations on the neighbouring community;
9. Fostering the sustainable use of the Earth's resources by "treading lightly", recognising the approach of Australia's Indigenous people in minimising our impact on the land;
10. Protecting natural resources, wildlife and endangered species, and the management of these natural resources for future generations;
11. Actively promoting environmental awareness to the community;

12. Ensuring all Healesville CoRE projects incorporate comprehensive environmental sustainability principles;
